Overview Of The Application Process

At the time of application for Regular Membership into The Association, an applicant must be at least twenty-one (21) years of age, have at least one (1) year of play time and have played at least twelve (12) times in either a commercial beach or shag lounge, or for an ACSC social shag club (or some combination of both) during the calendar year immediately preceding such application.

Applicants for Regular membership shall submit as a minimum:

- 1. A completed membership application package that includes the four previous pages (completely filled out) with sponsorship by at least one current member in good standing.
- 2. A letter of recommendation from a qualifying commercial beach or shag lounge signed by the lounge owner/manager and/or a letter from the president of an Association Of Carolina Shag Clubs social shag club. (Other supporting letters are encouraged.)
- 3. An application fee of \$300.00 that will be refunded if the application is declined.

Note: If there are any deliberate misrepresentations on the application, the application will be denied and the sponsor may be referred to the Ethics Committee for appropriate action.

The Membership Chairman will submit the application package to the Executive Board and appoint up to a three-member team to visit when the prospective member is playing to evaluate the prospect's efforts as a D.J. The visiting members will report back to the Executive Board as soon as possible and, in all cases, before the application is presented to the membership for voting.

Approved applications will be presented to the membership to be voted on at a general meeting.

Note: The applicant and their sponsor must be at the meeting for a vote to be taken.

Other Information

Your membership will become inactive for reasons including, but not limited to a failure to pay dues in a timely manner, a failure to attend one meeting or mini meeting during the year, a failure to pay money due to The Association of another member, or serious misconduct.

By submitting an application, you agree to abide by all present and future policies, rules and By-Laws of The Association and conduct yourself in a way that reflects positively on the Association.
